All waste medicines should be disposed of correctly and safely and not in your own refuse bin. Our practice provides a disposal service of waste medicines, sharps (injections) and other devices. If you have any unused medicines, including out of date medicines, or over the counter products (this does not include hazardous substances) please ensure they are returned either to your local GP surgery or pharmacy for safe disposal.

Do you forget to remember to order your medication? ABOUT THE PRACTICE AND OUR AIM

We are a very busy 5 Doctor Practice providing dispensing services to approximately 2,800 patients every month which is around half of the practice population.

We dispense around 6,000 items on average each month which is around 200 items a day. Our aim is to provide a friendly, efficient service to all of our dispensing patients.

As a dispensary within a GP practice, we can provide dispensing services to all patients in an area around a 1.6km radius from a dispensing pharmacy.

We cover all surrounding villages including some areas of Mundesley and North Walsham, all of Gimingham, Trimingham, Northrepps, Southrepps, Sidestrand, Antingham, Thorpe Market, Knapton, Paston, Bacton, Walcott, Happisburgh, Swafield, Ridlington, Bradfield, Overstrand, Edingthorpe, Witton and Trunch. The practice has extended it's boundary, so our outer boundary now covers Cromer, Roughton, Hanworth, Alby with Thwaite, Suffield, Erpingham, Ingworth, Colby, Felmingham, Skeyton, Swanton Abbott, Westwick, Scottow, Sloley, Worstead, Dilham, Honing and East Ruston.

If you live in one of the above villages and are more than 1.6km from a pharmacy and are not signed up for dispensing services within the practice, please make enquiries at dispensary reception.

WHAT SERVICES DO WE PROVIDE

Online Ordering Service.

We provide an online ordering service for all patients who are linked to the internet. This allows ordering of prescriptions online with ease along with providing regularly updated information on other services including the booking of routine appointments. For further information please enquire at the surgery to register your details and pick up your unique password.



Delivery Service for medicines only.

We offer a delivery service to all dispensing patients registered within the practice. This is a voluntary service. We deliver medicines to all areas covered within the practice boundary. Information on this is available on request.
